Incidents involving radiological materials attract much attention and concern, often placing unique demands on local emergency services. The potential danger to human life and property associated with exposure to and contamination from radioactive materials requires specialized preplanning efforts by local officials.

Preplanning for radiological emergencies is predicated on several reasons. First, technological advances in the nuclear industry have resulted in the increased production of new radioactive products. With the development of these products, potential hazards are created. Second, radioactive products are being transported at increased rates through local jurisdictions. Local officials are often unaware of this movement of nuclear wastes and other radioactive products. Finally, incidents at nuclear power plants can result in mass radiation exposure. This potential danger was most evident at the Three Mile Island reactor emergency that occurred in March 1979 in Middletown, Pennsylvania. Statistics show that as of 30 June 1980, there were 73 nuclear power reactors, 87 under construction, and 17 more planned in the United States. The sheer number of these sites reinforces the need for effective preplanning efforts by local response agencies.

Preplanning for radiological emergencies includes both fixed facility and transportation incidents. In fixed facility incidents, pre-emergency planning entails close coordination and cooperation between proprietors and local emergency response agencies. Responders must be familiar with the facility's products, building construction and layout, and access routes. In both fixed facility and transportation emergencies, procedures must be developed for immediate emergency response and potential secondary impact. These incidents have a rapid onset and an uncertain area of impact. They can vary in size and scope and in number of people affected.

Effective preplanning for radiological emergencies is comprised of several areas. These areas include evacuation, control of fire, rescue, care of contaminated victims, and transport. Other essential areas include communications and care of emergency personnel.

Emergency responders need specialized training and equipment to manage radiological emergencies. Basic training in the use of detection devices such as radiation survey meters is important. Equipment must be available to assess the size and involved areas of a potential release and to confirm the actual occurrence. In addition, emergency personnel should be able to identify the type of release, such as exposure to air, water, or food systems.

Based on the survey responses, training for emergency personnel is generally provided by state and local emergency preparedness agencies. Most of the training is focused on the use of basic detection devices. In some communities, such as those housing nuclear power plants in their response areas, more extensive training for emergency personnel may be provided. The San Clemente, California Fire Department, for example, with a response area of 15 square miles and a population of 27,000, has all department fire-fighters trained as radiological meter operators through the California Office of Emergency Services. At least nine additional personnel, in three shifts, are trained as a specialized monitoring team. Three personnel are trained as radiological defense officers.

In general, most agencies rely on fire and rescue units equipped with specialized monitoring equipment to serve as radiological response teams. Several of the teams identified in

the directory operate as both hazardous materials and radiological response teams. The Sacramento, California Fire Department, one such team, considers radiological products as one of the eight hazardous materials included in its response capabilities.

In many communities housing nuclear power reactors, local response plans have been developed. The San Clemente Fire Department and Office of Emergency Services have developed a "Nuclear Power Plant Radiological Emergency Response Plan," which is annexed to the City of San Clemente's Emergency Operations Plan. The plan establishes organizational responsibilities, planning and management guidelines, and identifies procedures to be enforced in the event of a radiological emergency at the nuclear power plant.

Local radiological response plans in communities are often prepared in cooperation with state plans. Frequently, the state plan is modified to meet local conditions. It is important that all plans be tested through the use of simulated exercises and modifications made, as necessary.

Many of the communities surveyed indicated that their locally developed training manuals are for both hazardous materials and radiological emergencies. Public and privately developed manuals are frequently used. State departments of emergency preparedness are often a source of training materials.

State radiological offices can provide assistance to local officials in their planning efforts. Other resources include chemists, engineers, and medical physicists located in most major medical facilities. Higher educational institutions may provide further resources.

Most of the reference materials available to local officials consist of federal publications. These references should be reviewed in preplanning for radiological emergencies.
