

V. NONSTRUCTURAL FIRES

Millions of fires occur annually in the United States. Most of these fires involve single and multifamily dwellings and commercial buildings. There are many fires, however, which are nonstructural, and cause significant loss to property, wildlife, and natural resources. Some of these fires may pose life safety problems. The major types of non-structural fires include wildlands, forests, mass transit systems, ships, and bulk petroleum storage facilities.

Wildland and forest fires are generally seasonal in nature. They may be caused by arson, negligence, or weather conditions. The major causes of mass transit, shipboard, and bulk petroleum storage fires are human error and negligence.

Regardless of the causes of nonstructural fires, communities must develop prefire plans. These plans should consider the many public and private resources available.

Training of personnel is an essential preplanning activity. Many communities have developed wildland fire training programs. The San Jose, California Fire Department, which has 78.13 square miles of wildlands in an expanded service area of 210 square miles and a population of 730,000, has developed an annual in-service wildland exercise. This exercise is conducted for all station personnel prior to the May-October wildland fire season. The training includes response, firefighter roles and responsibilities, types of fires, and new procedures. An additional eight-hour course is provided for those personnel assigned wildland emergency first response. This supplemental training course focuses on new tools and techniques. The course emphasizes the importance of teamwork among responding fire companies.

Due to the number of wildland calls experienced, the San Jose Fire Department has developed a multi-alarm, "tier-system" response. The system involves a progression of applications of available resources depending on the severity of the incident. The first-in unit makes the determination that additional units are needed. Basic equipment includes four-wheel drive vehicles, patrol tankers, and pumpers. Supplemental resources are provided by local organizations and the California Division of Forestry. Air surveillance is provided by the California Highway Patrol.

The San Jose Fire Department relies on a commercial wildland fire training manual. Both the Los Angeles and Los Angeles County Fire Departments have developed manuals for wildland fire training.

A second type of nonstructural fire involves mass transit systems. These systems can pose difficult firefighting and life safety problems. To improve their response to and management of mass transit systems, many communities have developed extensive preplanning efforts. Local communities in the San Francisco Bay area have preplanned fire operations since the opening of the Bay Area Rapid Transit (BART) Transbay Tube in 1972. The BART extends 3.6 miles under the San Francisco Bay between the cities of San Francisco and Oakland.

The San Francisco Fire Department, which has a response area of 49 square miles and a day population of one million, conducts monthly simulated exercises. These exercises involve a full first alarm assignment including three engine companies, two truck companies, one heavy rescue squad, and one attack hose tender. A communications vehicle (mobile command post) and an assistant and battalion chief also respond.

Training exercises on the BART are reviewed and evaluated. Additional preplanning is provided through weekly "walk-throughs" of the system by assistant and battalion chiefs. Semiannual mass casualty BART exercises are also conducted.

The response plan developed for the BART includes several components. These components are rescue, fire operations, logistics, and communications.

Many individuals and organizations are available to provide other resources to local communities. State fire marshals can assist in prevention and investigation while state training directors can provide instruction.

VI. NATURAL DISASTERS

Emergencies and disasters precipitated by natural causes can seriously stress the emergency services of any community. Natural hazards such as floods or tornadoes usually involve large land areas and cause significant damage to life and property. In most instances, the successful management of these incidents requires a multi-agency response. Thus, preplanning efforts for natural disasters necessitate a coordinated multi- or interagency approach.

Many communities, recognizing their risks for certain natural hazards, such as earthquakes or hurricanes, have developed specific preplanning efforts. The Los Angeles, California Fire Department, for example, which protects 467.63 square miles and a population of three million, provides training programs in earthquake preparedness for all officers and firefighters. Personnel are familiarized with the city's earthquake emergency mode through ongoing in-service training.

Another type of training effort exists in the City of Hampton, Virginia. The city, which has a history of major flooding problems due to its geographic location, has developed preplanning efforts for hurricanes including the conduct of an annual tabletop exercise. The exercise involves all city departments and requires department heads to simulate their roles and responsibilities. Participating departments include fire (with emergency medical service), police, civil preparedness, public health, public works, social services, and finance. Also included are the city manager, public information officer, and a representative from the American Red Cross. Specialized expertise in hurricane behavior is provided by a regional representative from the National Weather Service. The Virginia Office of Emergency and Energy Services provides staff support to evaluate the exercise.

Individual agency departments in the City of Hampton are expected to provide ongoing training efforts for hurricane preparedness. The Hampton Fire Department, protecting 55 square miles and a population of 125,000, continues its preplanning efforts through regular administrative meetings with station officers. On a monthly basis, station captains review their hurricane operating procedures and inform their personnel of any modifications.

In most communities surveyed, regular response units are used to manage incidents involving natural hazards. For incidents involving water, several fire departments maintain underwater recovery and water rescue teams.

Local and regional response plans exist in many communities. Individual agencies may have their own response plan as well as a plan annexed to the city/county plan. Several communities in the western United States have specialized plans for managing the effects of earthquakes. The Los Angeles, California Fire Department has recently prepared an "Earthquake Prediction Response Plan." The plan identifies the roles and responsibilities of fire department personnel when in a designated earthquake emergency mode.

The Aurora, Colorado Fire Department, with a response area of 65 square miles and a population of 175,000, has developed a response plan for flooding. The plan was prepared in recognition of the community's susceptibility to flash flooding from seasonal thunderstorms. The plan details the roles and responsibilities of fire personnel and

provides evacuation and reporting procedures. A call list is also provided. The plan is tested periodically through the use of simulated exercises.

None of the agencies surveyed indicated that they had a training manual for natural disasters. Other resources identified by the respondents included training efforts provided by federal and state emergency preparedness agencies. In addition, representatives from federal agencies such as the National Weather Service or National Hurricane Center are available to provide specialized expertise.

Relevant resource materials may be obtained from information clearinghouses operated by the University of Colorado's Natural Hazards Research and Applications Information Center and the Academy for Contemporary Problem's Natural Disaster Recovery and Mitigation Referral Service. The Ohio State University's Disaster Research Center can provide other relevant material.
